Food Waste Regulations for businesses in Northern Ireland

If your business undertakes processes or activities related to the processing, distribution, preparation or sale of food and produces more than 5kg of food waste per week, you must comply with the new Food Waste Regulations by 1st April 2017.

Food businesses includes

- Restaurants and cafes -
- Shopping and food courts
- Canteens
- Hotels
- Pubs that serve food
- Shops that serve food
- Supermarkets
- Schools/Colleges
- Prisons, nursing homes and hospitals

Food Waste Regulations

Food waste generated by food businesses to be separated for collection and recycling.

Appropriate systems should be established by a business that generates food waste to segregate and store it and to maintain quality prior to its collection.

The best way for your business to promote high quality recycling of food waste is to segregate it and to ensure that separate collection is possible by a waste management service provider.

Businesses that produce food waste should seek advice from their waste contractor on how to best present food for waste collection or alternatively read The Statutory Rules of Northern Ireland.
